### BUSINESS UPDATE

#### OPERATION DATA FOR WASTEWATER PROJECTS OF THE COMPANY

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 30 June 2018 is as follows:

As at 30 June 2018, the Company’s treatment capacity for (i) executed concession agreements was approximately 4.159 million tonnes per day, representing a growth of approximately 4.8% on a year-on-year basis; (ii) projects under operation was approximately 3.137 million tonnes per day, representing a growth of approximately 22.6% on a year-on-year basis; (iii) projects under construction was approximately 0.595 million tonnes per day, representing a decrease of approximately 21.2% on a month-on-month basis and a decrease of approximately 23.2% on a year-on-year basis; and (iv) projects to be operated was approximately 0.427 million tonnes per day, representing a growth of approximately 59.9% on a month-on-month basis and a decrease of approximately 32.8% on a year-on-year basis.
