## BUSINESS UPDATE

### Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 30 September 2017 is as follows:

As at 30 September 2017, the Company’s treatment capacity for (i) executed concession agreements was approximately 4.109 million tonnes per day, representing a growth of approximately 40.8% on a year-on-year basis; (ii) projects under operation was approximately 2.984 million tonnes per day, representing a growth of approximately 29.2% on a year-on-year basis and a growth of approximately 6.6% on a month-on-month basis; (iii) projects under construction was approximately 0.775 million tonnes per day, representing a growth of approximately 167.2% on a year-on-year basis; and (iv) projects to be operated was approximately 0.350 million tonnes per day, representing a growth of approximately 9.4% on a year-on-year basis and a decrease of approximately 34.6% on a month-on-month basis.
