BUSINESS UPDATE

Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 31 August 2017 is as follows:

As at 31 August 2017, the Company’s treatment capacity for (i) executed concession agreements was approximately 4.109 million tonnes per day, representing a growth of approximately 3.5% on a month-on-month basis and representing a growth of approximately 41.3% on a year-on-year basis; (ii) projects under operation was approximately 2.799 million tonnes per day, representing a growth of approximately 5.3% on a month-on-month basis and representing a growth of approximately 21.2% on a year-on-year basis; (iii) projects under construction was 0.775 million tonnes per day, representing a growth of approximately 167.2% on a year-on-year basis; and (iv) projects to be operated was approximately 0.535 million tonnes per day, representing a growth of approximately 72.6% on a year-on-year basis.
