Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 30 June 2017 is as follows:

As at 30 June 2017, the Company’s treatment capacity for (i) executed concession agreements was approximately 3.969 million tonnes per day, representing a growth of approximately 37.9% on a year-on-year basis; (ii) projects under operation was approximately 2.559 million tonnes per day, representing a growth of approximately 13.3% on a year-on-year basis; (iii) projects under construction was 0.775 million tonnes per day, representing a growth of approximately 98.7% on a year-on-year basis; and (iv) projects to be operated was approximately 0.635 million tonnes per day, representing a growth of approximately 176.1% on a year-on-year basis.
