The Board is pleased to announce that on 1 June 2017, the Water Department of Jiaoling County* (蕉嶺縣水務局), Kangda Group and Hunan Provincial Architectural Design Institute (湖南省建築設計院), after a competitive negotiation process, entered into the PPP Project Agreement in respect of the PPP Project for the domestic wastewater treatment in Jiaoling County, Meizhou City, Guandong Province, the PRC.

This announcement is made by the Company to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

INTRODUCTION

Reference is made to the announcement of the Company dated 19 May 2017 in relation to the successful competitive negotiation and entering into public notice period of the PPP Project.

The Board is pleased to announce that on 1 June 2017, the Water Department of Jiaoling County* (蕉嶺縣水務局), Kangda Group and Hunan Provincial Architectural Design Institute (湖南省建築設計院), after a competitive negotiation process, entered into the PPP Project Agreement in respect of the PPP Project for the domestic wastewater treatment in Jiaoling County, Meizhou City, Guandong Province, the PRC.

The PPP Project will be carried out through the public-private-partnership (commonly known as "**PPP**") model, which is an emerging cooperation model, supported by national policies, for the public and private sectors to work together under the leadership of the relevant PRC local government. While the PPP model typically involves the use of private

sector capital in public sector works, there is no fixed cooperation model, as the extent and nature of the private sector's involvements are driven by the requirements of the local government concerned.
