### **BUSINESS UPDATE**

#### **OPERATION DATA FOR WASTEWATER PROJECTS OF THE COMPANY**

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 31 October 2016 is as follows:

(Remark: the above statistics do not include the daily generation capacity of 40,000 tonnes recycling water from the participation in the Equity Transfer Agreement in relation to the acquisition of 100% of the equity interest in Qitaihe Wanxinglong Water Co., Ltd. as mentioned in the Company’s announcement dated 16 October 2016.)

As at 31 October 2016, the Company's treatment capacity for (i) executed concession agreements was approximately 2.969 million tonnes per day, representing a growth of approximately 1.7% on a month-on-month basis and a growth of approximately 16.3% on a year-on-year basis; (ii) projects under operation was approximately 2.309 million tonnes per day, representing a growth of approximately 9.1% on a year-on-year basis; (iii) projects under construction was 0.290 million tonnes per day, representing a decrease of approximately 21.6% on a year-on-year basis; and (iv) projects to be operated was approximately 0.370 million tonnes per day, representing a growth of approximately 15.6% on a month-on-month basis and a growth of approximately 469.2% on a year-on-year basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group. Shareholders and investors are cautioned not to unduly rely on such operation data and exercise caution in dealing in the securities of the Company.
