# SHANDONG PROVINCE FEICHENG CITY BIANYUAN WASTEWATER TREATMENT PLANT TOT PROJECT

The Board is pleased to announce that on 28 September 2016, the People's Government of Bianyuan County\* (邊院鎮人民政府) and Kangda Group entered into the Concession Agreement, pursuant to which Kangda Group shall be exclusively responsible for the operation and maintenance of the Target Project and Kangda Group shall be entitled to charge wastewater treatment fees based on the service provided.

This announcement is made by the Company to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

#### **CONCESSION AGREEMENT**

#### Date:

28 September 2016

#### Parties:

- (1) the People's Government of Bianyuan County\* (邊院鎮人民政府); and
- (2) Chongqing Kangda Environmental Protection Industry (Group) Co., Ltd.\* (重慶康達環保產業(集團)有限公司).

#### **Principal Terms**

Pursuant to the Concession Agreement, Kangda Group shall be exclusively responsible for the operation and maintenance of the Target Project and be entitled to charge wastewater treatment fees based on the service provided for a concession period of 30 years commencing from the commercial operation date of the Target Project. Upon the expiration of the concession period of the Target Project, Kangda Group shall transfer the Target Project to the People's Government of Bianyuan County\* (邊院鎮人民政府) or its designated entity for nil consideration.

The consideration for the transfer of concession right under the Concession Agreement was RMB30 million, which was negotiated by the Parties on arm's length basis. Pursuant to the Concession Agreement, Kangda Group shall pay the consideration in the following manners:

- (1) 30% of the consideration, i.e. RMB9 million, shall be paid within five (5) business days after the execution of the Concession Agreement;
- (2) 50% of the consideration, i.e. RMB15 million, shall be paid within five (5) business days after the completion of: (i) the People's Government of Bianyuan County\* (邊院鎮人民政府) has transferred the Target Project to Kangda Group and the Parties have duly signed the memorandum for completion of such transfer; (ii) the project company for the operation and maintenance of the Target Project has been established; and (iii) the Parties have confirmed in writing that the effluent has satisfied relevant standards set out in the Concession Agreement for consecutive fifteen (15) days after debugging; and
- (3) 20% of the consideration, i.e. RMB6 million, shall be paid within five (5) business days after the People's Government of Bianyuan County\* (邊院鎮人民政府) completes and transfers to Kangda Group relevant legal documents necessary for the Target Project, including but not limited to the land use right certificate, the land use agreement, the approval of environment assessment, the project approval, the preliminary design and its approval, the construction land use permit certificate, the construction project planning permit certificate, the construction permit certificate, the project completion and acceptance filing form and the approval of environmental acceptance.

The Target Project will further enhance the Group's capacity in wastewater treatment and consolidate the Group's leading position in the industry.
