BUSINESS UPDATE

Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 31 August 2016 is as follows:

(Remark: the above statistics do not include the participation in the Yunan County Entire County Domestic Wastewater Treatment Bundle PPP Project as mentioned in the Company’s announcement dated 4 August 2016 and the participation in the water supply and Drainage PPP Project in the urban area of Rushan City as mentioned in the Company’s announcement dated 18 August 2016.)

As at 31 August 2016, the Company’s treatment capacity for (i) executed concession agreements was approximately 2.909 million tonnes per day, representing a growth of approximately 1.0% on a month-on-month basis and a growth of approximately 14.0% on a

year-on-year basis; (ii) projects under operation was approximately 2.309 million tonnes per day, representing a growth of approximately 2.2% on a month-on-month basis and a growth of approximately 10.4% on a year-on-year basis; (iii) projects under construction was 0.290 million tonnes per day, representing a decrease of approximately 26.6% on a year-on-year basis; and (iv) projects to be operated was approximately 0.310 million tonnes per day, representing a decrease of approximately 6.1% on a month-on-month basis and a growth of approximately 376.9% on a year-on-year basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group. Shareholders and investors are cautioned not to unduly rely on such operation data and exercise caution in dealing in the securities of the Company.
