BUSINESS UPDATE

OPERATION DATA FOR WASTEWATER PROJECTS OF THE COMPANY

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 28 February 2017 is as follows:

As at 28 February 2017, the Company’s treatment capacity for (i) executed concession agreements was approximately 3.569 million tonnes per day, representing a growth of approximately 27.5% on a year-on-year basis; (ii) projects under operation was approximately 2.509 million tonnes per day, representing a growth of approximately 4.6% on a month-on-month basis and a growth of approximately 11.1% on a year-on-year basis; (iii) projects under construction was 0.495 million tonnes per day, representing a growth of approximately 41.4% on a year-on-year basis; and (iv) projects to be operated was approximately 0.565 million tonnes per day, representing a decrease of approximately 16.3% on a month-on-month basis and a growth of approximately 197.4% on a year-on-year basis.
