**Operation Data for Wastewater Projects of the Company**

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 30 September 2015 is as follows:

As at 30 September 2015, the Company’s treatment capacity for (i) executed concession agreements was approximately 2.552 million tonnes per day, representing a growth of approximately 15.6% on a year-on-year basis; (ii) projects under operation was approximately 2.117 million tonnes per day, representing a growth of approximately 14.7% on a year-on-year basis and a growth of approximately 1.2% on a month-on-month basis; (iii) projects under construction was 0.370 million tonnes

per day, representing a growth of approximately 14.9% on a year-on-year basis and a decrease of approximately 6.3% on a month-on-month basis; and (iv) projects to be operated was approximately 0.065 million tonnes per day, representing a growth of approximately 62.5% on a year-on-year basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group.
