BUSINESS UPDATE

Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 30 June 2015 is as follows:

As at 30 June 2015, the Company’s treatment capacity for (i) executed concession agreements was approximately 2.522 million tonnes per day, representing a growth of approximately 31.6% on a year-on-year basis; (ii) projects under operation was approximately 2.092 million tonnes per day, representing a growth of approximately

43.3% on a year-on-year basis; (iii) projects under construction was 0.365 million tonnes per day, representing a growth of approximately 34.2% on a year-on-year basis; and (iv) projects to be operated was approximately 0.065 million tonnes per day, representing a decrease of approximately 64.9% on a year-on-year basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group. Shareholders and investors are cautioned not to unduly rely on such operation data and exercise caution in dealing in the securities of the Company.
