OPERATION DATA FOR WASTEWATER PROJECTS OF THE COMPANY

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 31 March 2016 is as follows:

As at 31 March 2016, the Company's treatment capacity for (i) executed concession agreements was approximately 2.839 million tonnes per day, representing a growth of approximately 14.8% on a year-on-year basis and a growth of approximately 1.4% on a month-on-month basis; (ii) projects under operation was approximately 2.259 million tonnes per day, representing a growth of approximately 8.5% on a year-on-year basis; (iii) projects under construction was 0.350 million tonnes per day, representing a growth of approximately 11.1% on a year-on-year basis; and (iv) projects to be operated was approximately 0.230 million tonnes per day, representing a growth of approximately 206.7% on a year-on-year basis and a growth of approximately 21.1% on a month-on-month basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group. Shareholders and investors are cautioned not to unduly rely on such operation data and exercise caution in dealing in the securities of the Company.
