BUSINESS UPDATE

Operation Data for Wastewater Projects of the Company

This announcement is made by Kangda International Environmental Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) to keep the shareholders and potential investors of the Company informed of the latest development of the Group.

Operation data of treatment capacity per day for wastewater projects of the Company as at 31 May 2015 is as follows:

As at 31 May 2015, the Company’s treatment capacity for (i) executed concession agreements was approximately 2.522 million tonnes per day, representing a growth of approximately 39.7% on a year-on-year basis and a growth of approximately 2% on a month-on-month basis; (ii) projects under operation was approximately 2.092 million tonnes per day, representing a growth of approximately 43.8% on a year-on-year basis and a growth of approximately 0.5% on a month-on-month basis; (iii) projects under construction was 0.365 million tonnes per day, representing a

growth of approximately 19.7% on a year-on-year basis and a growth of approximately 15.9% on a month-on-month basis; and (iv) projects to be operated was approximately 0.065 million tonnes per day, representing a growth of approximately 44.4% on a year-on-year basis and a decrease of approximately 13.3% on a month-on-month basis.

The board of directors of the Company wishes to remind investors that the above operation data are unaudited and are based on internal information of the Group. Shareholders and investors are cautioned not to unduly rely on such operation data and exercise caution in dealing in the securities of the Company.
